- Work Groups (Community/School Engagement, Housing Advocacy, Transportation, Crisis Response Team)
  Community/School Engagement: Havre Trauma Sensitive School Initiative continues to meet. There will be a 3-hour training/workshop in August.
  - Housing Advocacy-Jasmine motioned to suspend work groups for Transportation and the Crisis Response Team and focus on housing issues in Hill County. Sandy Derry seconded the motion. All members present in favor.
  - -Sandy will reach out to the Landlord Association to determine when their next meeting is and investigate the development of the Risk Assessment.
  - -Lenore Myers will reach out to the Re-Entry Task Force and identify possible resources.
  - -Sandy reported there is nothing stating landords are required to do a risk assessment for individuals with felonies.

Mental Health First Aid-Darlene Sellers proposed the following:

"The cost of each MHFA participant manual (adult and youth) is approximately \$22.00. For the trainings to date, LAC has purchased the manuals for all participants regardless whether an organization was sending its employee to the training or if the participant was a member of Hill County or a nearby community. This motion is to establish the practice of passing on the cost for participant manuals (\$22.00 for each manual) to organizations whose employees complete the trainings and for to continue to provide Hill County

community members the manuals at no cost until such a time when LAC procures financial support to supply all manuals for those who complete the MHFA training, including local, Hill County organizations' employees."

Darlene Sellers motioned to approve the proposal as written. Jasmine seconded the motion. All members present in favor of the proposal.

Jasmine made the motion for Darlene to order workbooks for the upcoming Mental Health First Aid Course and for the LAC to fund the purchase and be reimbursed by participants at the time of registration. Sandy Derry seconded the motion. All members present were in favor of the purchase.

Jasmine reported she will be a referral source for individuals who are interested in taking the adult Mental Health First Aid course and are unable to pay the \$22.00.

Lenore Myers reported they may have extra Mental Health First Aid books at Rocky Boy that they would be willing to donate to the LAC. Lenore reported there may be a possibility that White Sky Hope would sponsor an upcoming Mental Health First Aid course.
